# Vermont Outdoor Business Alliance

Dear Vermont outdoor businesses and organizations - First and foremost, we hope your families, neighbors, and employees are safe.

As you know, Governor Phil Scott has [declared a State of Emergency](#) in

Vermont due to severe rainfall and flooding across the state and the Vermont Emergency Management Center is deploying resources. If you are currently in a situation that needs immediate support, [Vermont 211](#) is the most direct way to reach state emergency management officials, and as always, report any emergencies to 9-1-1.

The Agency of Commerce and Community Development (ACCD) is working to keep apprised of what communities and businesses are experiencing as an evolving situation and/or in terms of severe damage.

State Emergency Management officials will be working with FEMA and the U.S. Small Business Administration on a disaster declaration which will allow for federal assistance in repairing damage from this storm. In the days ahead and when it is safe to do so, **it important to document any damage and estimate the cost of damage to outdoor recreation businesses and infrastructure to help the state's disaster declaration criteria.**

If you are in a position to share what you are experiencing or hearing from the outdoor recreation community, VOBA is a liaison with ACCD and will be reporting outdoor sector needs and impacts to inform the ongoing response and recovery. VOBA will be conveying available resources through our communications.
