HELP FUND TRAIL REPAIR: TRAIL IMPACT ESTIMATES NEEDED BY AUGUST 7

VTGC needs your help advocating for funding and legislative support to repair Vermont's trail infrastructure impacted by the recent flood events. We are asking all organizations in Vermont that steward trails to help us tell the story. Were your trails washed out? Parking lots destroyed? Bridges and culverts damaged? Have you deployed volunteers for repair and reallocated limited funds and staff or volunteer time to recovery efforts? **Please populate this spreadsheet with your organization's information by August 7th.** VTGC will consolidate this information and communicate our collective need to the State, working closely with VT-FPR. The more we can paint a full picture of how the flood has damaged trails and our organizations collectively, the better chance we have at securing support for us all. Not finished assessing the damage? Don't have any or much damage? No problem. **Our goal for the moment is to generate a ballpark sense of the impacts and we want to hear from everyone.** Have a bigger story to tell than fits in a spreadsheet? FUNDING

- The [Vermont Community Loan Fund's TRAILS](#) Loan Program: financing is available to businesses and organizations that provide services or goods that enable, support or are adjacent to Vermont's outdoor recreation industry
- Right now, FPR is pursuing more information on possible opportunities for tapping into FEMA support for recreational trails. Presently, recreation nonprofits are NOT eligible for FEMA funds, though municipalities may apply for recreational infrastructure impacts, including trails.
- FEMA currently has 330 people on the ground in Vermont and they have been setting up [Multi-Agency Centers \(MARCs\)](#) around the state. These centers are a single location where public and private organizations come together to provide assistance to those affected by disaster. The U.S. Small Business Administration (SBA) has also set up Recovery Centers in Washington County at the Vermont Chamber of Commerce and in Windsor County at the Engel & Völkers Okemo Building. You can find more information on ACCD's Flood Recovery Resource Center.
- The [US Small Business Administration](#) is offering low-interest loans in affected areas.
- [Vermont Community Foundation Flood Response Recovery Fund](#) has raised more than \$2.5 million for flood relief. The fund will be used in three phases including: Phase 1: Immediate Response, Relief Phase 2: Building Back Communities, and Phase 3: Community and Watershed Resilience. To date, more than \$1 million has been granted.
- The [Main Street Recovery Fund](#) provides \$2,500-\$10,000 grants for businesses to obtain immediate bridge assistance.
- [Vermont Outdoor Recreation Economic Collaborative \(VOREC\)](#) Flood Recovery Resources website has a consolidated list of useful links
- [Common Good Vermont](#) has an excellent Nonprofit Flood Response & Recovery Information page with resources and information
- [Vermont Outdoor Business Alliance \(VOBA\)](#) has a resource page specific to flood resources aimed at supporting affected businesses and communities.
- The Department of Buildings and General Services (BGS) has announced that the [Building Communities Grants Program](#) has been funded for FY2024. These grants are for construction and capital improvements to support and strengthen Vermont towns and regions. \$300,000 is available for Recreational Facilities and another \$300,000 for Regional Economic Development grants, with additional funds available for Human Services and Educational Facilities. Head to the [BGS website](#) for application criteria.
The grant deadline is September 10.

ADDITIONAL ASSESSMENT RESOURCES

- Assessment work to understand damages is underway on State land. ANR is using this Forestry Field Assessment form and members are welcome to use it for their purposes. Please note: it is specific to FEMA and it is not yet known to what extent, if at all, FEMA will cover damages on private lands.
- VAST has put out the word to volunteers to document damage. They would like clubs to report trail damage using [this form](#).
- The Solocator app (solocator.com) is a useful tool for documenting storm damage. It allows you to take photos of damaged trail sections with your phone and then attach them to assessment forms. The app automatically assigns a GPS point to each photo for reference.
- Trail managers on public lands have found pages 58 & 59 of this [FEMA guidebook](#) helpful when developing spreadsheets and other forms for documentation. You should also be working closely with the land manager, who will be the assistance applicant.
