## Meeting summary

#### Agenda Item/ Meeting Feedback

#### 1. Opening Reflections

The attendees shared what excites them most about the direction of Outdoor Recreation. High level themes:

- Outdoor Rec offers:
  - Mental Health and Nature
  - Broader interest to connect everyone outside
  - Build long term community through experience with nature and natural resources assets
- Trends/Opportunities in the space include:
  - Recognized as part of the institutions for community
  - Another option for Community Economic development tools
  - Opportunity to leverage gateway communities
  - More people getting into space
- o Reputationally, there is a need address the perceptions:
  - Marketing
  - Destination market
  - Driver of balance

#### 2. Review Draft Vision/Priorities

The attendees provided feedback on the draft MFTV Vision/Priorities. The key themes included:

- Areas to clarify
  - o What or will there be specifics?
  - o Is there going to be how?

- Feedback on Guiding principles
  - o Reads well
  - o Not all groups agree on the definition of outdoor rec. Might need to clarify.
  - o Consider a definition section for outdoor rec. economy
- Community
  - o First sentence captures well
- Priorities
  - o Consider doing only three:
    - Stewardship, Wellness, Econ. Dev.
- Discussion on moving climate/equity as through lines:
  - Consider risks with list
  - o Increases the emphasizes and their importance
  - o Need to align with state partners
  - o Repeated word invest but if more than \$ (people, etc.)
  - Opportunity word choice pros/cons
    - Equity is stronger word choice

#### 3. VOREC's Purpose and Charter (Exec. Order 11-17)

Jackie started the meeting at 10:03 a.m. and reviewed the agenda.

The steering committee introduced themselves.

#### **Business Meeting**

Jackie opened the floor acknowledging the floods that have impacted the outdoor recreation economy and that there are many projects ongoing. She invited steering committee members to share updates with the group.

Karrie – Work is going well to start assessments of the accessibility of waterways as part of the VOREC Community Grants Program (VCGP) Trail Accessibility Hub grant. She also noted that they have been doing a survey of people with disabilities which shows the importance of the work to people who don't currently have access.

Tommy – ATV clubs have been helping with mucking out homes as well as search and rescue in the North East Kingdom (NEK). Hearing about VCGP grants on a lot of angles, will be volunteering with Stowe Adaptive to help test the TetraSki.

Shelby – Thanked Abby for putting a call out for volunteer help in the NEK. A lot of organic networks have been doing amazing work on recovery and speaks to the value of convening people. A story ran in

the local paper in the Mad River Valley about damage to snowmobile trail network that's looking at \$400K in trail damages. Wolcott Community Forest next to the local elementary school is poised to close next month, but trail construction is ongoing. There are opportunities for growth in Wolcott related to the project and TPL has been engaged in work to look at opportunities for affordable housing, brownfields, and the sighting of a recreational hut.

Abby – Kingdom Trails (KT) was devastated by the two NEK flooding events, plus hurricane Debbie that came at the end of the month. They experienced \$300K in damages (and this does not include membership revenue losses. This is only physical damage of bridges, culverts, material, and labor). Many of the trails and bridges impacted are shared with the Vermont Association of Snow Travelers (VAST). There is risk that some trails will never be re-opened as bridges lost will be an incredible cost/engineering feat. KT, just this week, was finally able to open majority of trails. They have made band-aid fixes for now, just to get them open, but this is not a forever fix. There's a need for funds that can help consistently maintain trails!! KT is one of the economic drivers in in the NEK and when KT is impacted, EVERYONE is impacted. KT is very fortunate to have a paid trail crew they can immediately deploy – but others don't.

Capital for the Day is headed to KT this Tuesday and there will be an opportunity to share with the administration, alongside others from the NEK, what the needs are - consistent/dedicated state funding for trail stewardship and resiliency.

Josh – Timber & Stone, LLC is in it's 21<sup>st</sup> season of trailwork. Celebrating with the largest and most talented crew they have ever had and the largest season. Checked on the trails that they have built and 90% were still there and functional. Despite that, they are adjusting trail construction methods, particularly in areas where water is moving fast through the woods. Need to think on larger scales when thinking about trail design. Some of these events are changing the topography through mud slides and landslides.

Kelly – VOBA is working with businesses to think about and build climate resilience. Convened two focus groups for Move Forward Together Vermont (MFTV). Looking to leverage research to inform how businesses can adapt to climate change. Appreciated participating in Capital for a Day in Waterbury in early August. Flooding closed Village Sports in downtown Lyndonville because entire rental fleet was damaged. Excited that advocacy in the last legislative session has led to \$5M towards another round of the Business Emergency Gap Assistance Program (BEGAP) and another \$7M has been authorized. Important for filling the revenue gap along with the Small Business Association (SBA) loans following the acceptance of the disaster declaration.

Karrie – Asked about how tourism is understanding the flooding.

Heather – Acknowledged that there is an impact to tourism, especially with news stories of devastation. It is helpful to remember that we are not alone and many of the visitors coming to Vermont are experiencing major climate events where they live as well. We can learn from resilience of communities across the country. Feeling optimistic about messaging about our resilience in order to protect the Vermont brand and visitorship.

Karrie – Responded that this also shows how the state is interconnected and how important it is to work together.

Frazier – There are some difficulties in the outdoor business sector. There aren't a lot of brands hitting their sales plans, including Orvis. There are also looming supply chain issues. These supply chain issues are being caused by a pending contract expiration which requires re-negotiation along the whole east coast. The contract is set to expire at the end of September and renew on October 1. If the negotiations don't go well, it could cause a port shut-down. A port-shut down is unlikely to go very far since it is an election year. Shut-downs slow delivery of goods and creates congestion in other ports. There's some railway stuff going on in Canada which slows things down, and freight can be re-routed to the west coast if east coast ports are closed causing additional congestion. Slow downs impact anyone shipping to or from the United States.

Frank – Flooding has impacted fishing and the guiding industry. Access in some areas was damaged, but work is being done to repair for fall and winter.

Jackie – VOREC can sponsor one registration for the Vermont Recreation and Parks Association (VRPA) Vermont Conference on Recreation. She polled the group on interest.

Becca noted that we can open the registration spot to staff from Steering Committee member organizations who may be interested.

Becca – Gave any update on recruitment for the steering committee. Asked for suggestions for the non-profit seat that opened when Jeanne Gervais stepped down.

Former suggestions – VT Adaptive, Unlikely Riders, Come Alive Outside New suggestions – Local Motion, VYCC (Leah Mital), Craftsbury, NFC, Onion River Outdoors

Frazier suggested that more of a matrix of needs would be helpful. Also desire to engage and dig in is paramount to the needs of the committee.

Shelby suggested an addition to the process that would include existing committee members engaging with the potential new committee members.

#### **VOREC Program Update**

Jackie shared that the conversation this afternoon about the VOREC Program is an extension of the work the Steering Committee has been doing all year.

She continued that the goal throughout this year has been to establish a vision and set of priority actions for outdoor recreation in Vermont through MFTV. Following the end of the year, VOREC will be responsible for engaging a network of outdoor recreation partners and working together more actively on progress towards the MFTV Vision and Priority Actions. This will include working on the nuts and bolts of a workplan that will better define the who, what, and when of each of the priority actions.

To pull together the network and work on the next phase, VOREC needs to evolve. She provided a reminder that the Steering Committee has been working on evolving by clarifying and putting additional structure around the governance, operations and services of the VOREC program. Brainstorming conversations since early this year have highlighted ideas about VOREC's operational needs and critical services that can be provided to outdoor recreation partners. During the meeting in June the Steering Committee also identified five core areas for VOREC to work in: Storytelling, Policy, Data, Technical Assistance, Funding/Grants).

Jackie shared that now, the Steering Committee is taking the outcomes of those conversations and creating a document that codifies expectations for the program, and the working title for that document is the "Foundation Plan."

Jackie reviewed the proposed Table of Contents for the Foundation Plan and then asked for input from the steering committee on anything that was missing.

Shelby asked how much discussion VOREC has had with Farm to Plate since they support a robust network, although it may be a more formalized network.

Jackie responded that the group agreed in June that the Farm to Plate network was more structured than the VOREC program currently has capacity and interest in, but that it would be good to reach out to discuss the early stages of their network creation.

Jackie passed facilitation on to Andrew to lead the next discussion to further refine activities that VOREC should adopt into their annual operations and services to the network. Due to time limitations, the Steering Committee was unable to complete the exercise and Jackie and Andrew took an action item to further consider how best to follow-up.

#### **Move Forward Together Vermont Update**

Jackie provided overview of public engagement activities soliciting feedback on the draft vision and priorities. She shared that Staff reviewed public comments and assessed for themes. Public comments did not suggest drastic changes and in fact reinforced the accuracy of the outcomes.

Jackie shared that it was interesting to see that some comments suggested that the report should do more to highlight listening to specific groups while others suggested de-emphasizing the focus on specific groups.

One adjustment being proposed based on public comment is adding another section to the report that identifies next steps regarding who will be involved in implementing the vision and priority actions, where funding will come from, and how progress will be assessed.

Jackie highlighted that comments about youth and schools suggested that these groups should be drawn out more clearly. She shared that in speaking with the Statewide Comprehensive Outdoor Recreation Plan (SCORP) Technical Advisory Committee earlier in the week they didn't feel it was necessary to add youth and schools specifically to the priorities and that they are incorporated by virtue of the way the existing priorities are articulated.

VOREC Steering Committee members agreed that drawing out youth and schools in a new priority wasn't necessary, however, they expressed it will be important to highlight youth in particular because of how critical this group is in advancing the priorities.

Jackie adjourned the meeting at 12:32p.m.
